**Section 1.** The Mayor and Director of Public Safety are hereby authorized to enter on behalf of the City of Pittsburgh into a <u>an Amended</u> Professional Services Agreement or Agreements with Freedom Indeed LLC/Reverend Cornell Jones for professional services as a Group Violence Intervention Coordinator at a total cost not to exceed THREE HUNDRED TWENTY-SEVEN THOUSAND FOUR HUNDRED SIXTY-FIVE DOLLARS and NO CENTS (\$327,465.00) payable from the following accounts, subject to Council approval in future budget years:
