**Be it resolved by the Council of the City of Pittsburgh as follows:**

Section 1 of Resolution number 515 of 2019 is hereby amended as follows:

**Section 1.** The Mayor and the Director of Public Safety are hereby authorized and directed to enter on behalf of the City of Pittsburgh into a **an amended** two-year Professional Services Agreement or Agreements with a **City** one-year option to renew with The Center that CARES for the purpose of enhancing the continuum of services provided through the Pittsburgh Group Violence Intervention Street Outreach Program at a cost not to exceed Nine Hundred Thirty Seven Thousand Five Hundred Dollars and No Cents (\$937,500.00), chargeable to and payable from the following:
