Resolution providing for a supplementary Agreement with Allegheny County for local costs associated with the 10<sup>th</sup> Street Bridge project, and providing for the payment of municipal incurred costs thereof, not to exceed Ninety Eight Thousand One Hundred Forty Four Dollars and Seventy Three Cents (\$98,144.73).

**Be it resolved by the Council of the City of Pittsburgh as follows:**

**Section 1.** The Mayor and the Director of the Department of Mobility and Infrastructure, on behalf of the City of Pittsburgh, are hereby authorized to enter into a supplementary agreement with Allegheny County for the payment of local costs associated with the 10<sup>th</sup> Street Bridge Project being undertaken by the County, and further providing for payment of costs not to exceed Ninety Eight Thousand One Hundred Forty Four Dollars and Seventy Three Cents (\$98,144.73), representing an increase of Forty Two Thousand One Hundred Forty Four Dollars and Seventy Three Cents (\$42,144.73) from the original agreement, as authorized by Resolution 312 of 2015), payable from the following account:
