Resolution authorizing the Urban Redevelopment Authority of Pittsburgh to acquire all the City's Right, Title and Interest, if any, in and to the following Publicly-Owned property in the 13<sup>th</sup> Ward of the City of Pittsburgh designated in the Deed Registry Office of Allegheny County as Block 174-J, Lot 308 located at 803 N. Homewood Ave (Council District No. 9).

**WHEREAS**, the Urban Redevelopment Authority of Pittsburgh desires to acquire all the City's right, title and interest, if any, in and to the above-listed publicly-owned property in the 13<sup>th</sup> Ward of the City of Pittsburgh, for the sum of \$1.00 plus all necessary and incidental expenses in connection with such acquisition.

**WHEREAS**, the Council of the City of Pittsburgh desires to give approval to the acquisition by Urban Redevelopment Authority of Pittsburgh.

### Be it resolved by the Council of the City of Pittsburgh as follows:

**Section 1.** That the Urban Redevelopment Authority of Pittsburgh is hereby authorized to acquire, for the sum of \$1.00 plus all necessary and incidental expenses in connection with such acquisition, all the City's right, title and interest, if any, in and to publicly-owned property known as Block 174-J, Lot 308 in the 13<sup>th</sup> Ward of the City of Pittsburgh.

**Section 2.** That the Urban Redevelopment Authority of Pittsburgh is authorized to incur said necessary and

incidental expenses in connection with said acquisition.
