Resolution approving Execution of a Contract for Disposition by Sale of Land between the Urban Redevelopment Authority of Pittsburgh and Bree Piper, for the sale of Block 50-M, Lot 208, located on the south side of Hillcrest Street, east of N. **WHEREAS**, the above property was purchased using the Residential Land Reserve Fund.

**WHEREAS**, the Urban Redevelopment Authority of Pittsburgh has requested authorization to execute a Contract for Disposition by Sale of Land by and between the Urban Redevelopment Authority of Pittsburgh and Bree Piper, in connection with the sale of Block 50-M, Lot 208 in the 11<sup>th</sup> Ward of the City of Pittsburgh, for the sum of \$7,500.00 plus costs; and

**WHEREAS**, the Council of the City of Pittsburgh believes that the proposed Contract is in the best interest of the City of Pittsburgh and desires to give its approval in accordance with the provisions of the Urban Redevelopment Law.

**Be it resolved by the Council of the City of Pittsburgh as follows:**
