Resolution authorizing the Mayor and Director of the Department of Mobility and Infrastructure to execute relevant agreements to receive grant funding from the Pennsylvania Department of Community and Economic Development's Multimodal Transportation Program for the design and construction of street and sidewalk infrastructure and pedestrian/plaza space at and near the intersection of Beechview Ave and Broadway Ave and further providing for an agreement and expenditures not to exceed SIX HUNDRED THOUSAND (\$600,000.00) dollars for this stated purpose.

### Be it resolved by the Council of the City of Pittsburgh as follows:

**Section 1.** The Mayor and the Director of the Department of Mobility and Infrastructure of the City of Pittsburgh are authorized to execute relevant agreements with the Pennsylvania Department of Community and Economic Development in order to receive a grant award in the amount of SIX HUNDRED THOUSAND (\$600,000.00) dollars for the purpose of design and construction of street and sidewalk infrastructure and pedestrian/plaza space at and near the intersection of Beechview Ave and Broadway Ave. Monies from the grant agreement shall be deposited into the Grants Trust Fund Account 6029400348.45505.00.

**Section 2.** The Mayor and the Director of the Department of Mobility and Infrastructure are further authorized to enter into Agreements, or Contracts, or utilize existing Agreements or Contracts not to exceed

SIX HUNDRED THOUSAND (&600,000.00) dollars for the purpose of design and construction of street and sidewalk infrastructure and pedestrian/plaza space at and near the intersection of Beechview Ave and Broadway Ave under the terms of an agreement between the City of Pittsburgh and the Pennsylvania Department of Community and Economic Development. Costs are chargeable to and payable from the Grants Trust Fund account 6029400348.50000.00.
