Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1. The Mayor and Director of the Department of Public Works are authorized to apply for grant funding from the Pennsylvania Department of Conservation and Natural Resources' Community Conservation Partnerships Program, to provide funding for the West Penn Playground Reconstruction Project. The total project cost is \$200,000.00. The grant proposal includes an request of \$100,000.00 with a local match of \$33,000.00 be funded from the 2022 City of Pittsburgh Operating Budget in the form of in-kind work and \$67,000.00 from the 2022 City of Pittsburgh Capital Budget (JDE JOB NO. 4510020122). In the event the grant is awarded, this resolution provides for an agreement and expenditures not to exceed TWO HUNDRED
