Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1. The Mayor and the Director of the Department of Parks and Recreation to enter on behalf of the City of Pittsburgh into an <u>amended</u> agreement or agreements with Allegheny County, Department of Human Services, for the City's operation of its Senior Community Centers. Said <u>amended</u> agreement or agreements shall be for a term of one year at no cost to the City and with compensation to the City in the amount of <u>EIGHT HUNDRED FOUR THOUSAND TWO HUNDRED SEVENTY-SEVEN DOLLARS and FOUR CENTS (\$804,277.04)</u>. SEVEN HUNDRED EIGHTY THREE THOUSAND and FOUR HUNDRED FIFTY DOLLARS and NO CENTS (\$783,450.00).
