Resolution amending Resolution No. 699 of 2019, which authorized the City of Pittsburgh to enter into a Professional Service Agreement(s) with P&A Group for services relating to the administration of the City of Pittsburgh's Consolidated Omnibus Budget Reconciliation Act (COBRA) program, by exercising the written option to extend the term of the contract by two years at a cost not to exceed Ninety Thousand Dollars (\$90,000.00).

Be it resolved by the Council of the City of Pittsburgh as follows:

Resolution No. 699 of 2019, entitled "Resolution amending Resolution No. 742 of 2017, which authorized the City of Pittsburgh to enter into a Professional Service Agreement(s) with P&A Group for services relating to the administration of the City of Pittsburgh's Consolidated Omnibus Budget Reconciliation Act (COBRA) program, by increasing the authorized spending amount by Ninety Thousand Dollars (\$90,000)", is hereby amended as follows:

Section 1. The Mayor and the Director of the Department of Human Resources and Civil Service, on behalf of the City of Pittsburgh, are hereby authorized to enter into an Agreement or Agreements with P&A Group for services relating to the administration of the City of Pittsburgh's Consolidated Omnibus Budget Reconciliation Act (COBRA) program for sum not to exceed **Two Hundred and Forty Thousand Dollars (\$240,000.00)** over **six** years, subject to annual appropriation by City Council for future years, subject to annual appropriation by City Council for future years.
