Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1. Resolution authorizing, pursuant to Ch. 210 (“Acceptance of Gifts to City”) of the City Code, the Mayor and the Director of the Department of Mobility & Infrastructure, to accept a donation from Jewish Community Center of Greater Pittsburgh in the amount of TWELVE THOUSAND FIVE HUNDRED (\$12,500.00) DOLLARS for traffic calming on Darlington Road. Donated monies shall be deposited into JDE account string 6074011821.48311.00. Costs are chargeable and payable from JDE account string 6074011821.50000.00.
