Resolution authorizing the Urban Redevelopment Authority of Pittsburgh to acquire all the City's Right, Title and Interest, if any, in and to the Publicly-Owned property in the 18<sup>th</sup> Ward of the City of Pittsburgh designated in the Deed Registry Office of Allegheny County as Block 14-A, Lot 247, located at the southwest corner of Ceres Way and Pedro Way (Council District No. 3).

**Whereas,** the Urban Redevelopment Authority of Pittsburgh desires to acquire all the City's right, title and interest, if any, in and to the above-listed publicly-owned property in the 18<sup>th</sup> Ward of the City of Pittsburgh, for the sum of \$1.00 plus all necessary and incidental expenses in connection with such acquisition.

**Whereas,** the Council of the City of Pittsburgh desires to give approval to the acquisition by Urban Redevelopment Authority of Pittsburgh.

## Be it resolved by the Council of the City of Pittsburgh as follows:

**Section 1.** That the Urban Redevelopment Authority of Pittsburgh is hereby authorized to acquire, for the sum of \$1.00 plus all necessary and incidental expenses in connection with such acquisition, all the City's right, title and interest, if any, in and to the publicly-owned property known as Block 14-A, Lot 247, in the 18<sup>th</sup> Ward of the City of Pittsburgh.

Section 2. That the Urban Redevelopment Authority of Pittsburgh is authorized to incur said necessary and
