Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1. The Director of the Department of Parks is hereby authorized to enter on behalf of the City of Pittsburgh into agreements in individual amounts of Ten Thousand Dollars (\$10,000) or less with various youth sports organizations for community-based athletic and recreational activities conducted in the City.
