Resolution authorizing the Mayor and the Director of City Planning to enter into a Professional Services Agreement with McKay Lodge Conservation Laboratory for conservation and preparation services for the Virgil Cantini Mural relocation project for an amount not to exceed Three Hundred Fifty-One Thousand and Ninety-Three Dollars (\$351,093.00).

**WHEREAS**, the Cantini mosaic is a piece of City-owned artwork formerly installed in a pedestrian underpass below Bigelow Boulevard, and removed during the construction of the I-579 “Cap” Project; and

**WHEREAS**, being a historically and culturally valuable asset, it was determined that the mosaic should be preserved and reinstalled in a suitable location; and

**WHEREAS**, the mosaics require restoration and preparation services prior to reinstallation; and

**WHEREAS**, McKay Lodge Conservation Laboratory is possessed of professional experience and skill uniquely suited for this work.

**Be it resolved by the Council of the City of Pittsburgh as follows:**

**Section 1.** Resolution authorizing the Mayor and the Director of City Planning to enter into a Professional

Services Agreement with McKay Lodge Conservation Laboratory for restoration and preparation services for the Virgil Cantini Mural reinstallation project for an amount not to exceed Three Hundred Fifty-One Thousand and Ninety-Three Dollars (\$351,093.00)., charging to fund 40022, JDE account 1173400122.53901.00.

**Section 2.** The agreement shall be in a form approved by the Solicitor.
