WHEREAS, the City of Pittsburgh requires as part of its Independence Day Festival, professional services for a fireworks display; and

WHEREAS, Zambelli Fireworks Manufacturing Co., was selected through a competitive process as qualified for the performance of said professional services; and

WHEREAS, the City of Pittsburgh now wishes to enter into an agreement with Zambelli Fireworks Manufacturing Co., for the performance of a fireworks display in conjunction with the City of Pittsburgh's Independence Day Festival.

Be it resolved by the Council of the City of Pittsburgh as follows:
