Resolution 347 of 2020 is amended as follows:

**Section 1.** Resolution authorizing the Mayor and the City Solicitor to enter into a Professional Services Agreement with Cozen O'Connor, One Oxford Centre, 301 Grant Street, 41<sup>st</sup> Floor, Pittsburgh, PA 15219 for professional legal services in connection with an employment related matter at a cost not to exceed **Forty Fifteen** Thousand Dollars and No Cents (**\$40,000.00**), chargeable to and payable from the following JD Edwards Accounts:
