Resolution authorizing the Director of the Department of Finance and the Director of the Department of Mobility and Infrastructure, on behalf of the City of Pittsburgh to enter into an Agreement of Sale with various property owners in the 18<sup>th</sup> and 19<sup>th</sup> Wards of the City in order to advance the Mt. Washington Landslide Remediation Project.

WHEREAS, to advance the project, access to certain parcels of property within the project area are necessary for safe movement of construction equipment in addition to grading and other construction activities, and;

WHEREAS, the City of Pittsburgh seeks to enter into an agreement of sale with various property owners in order to allow for necessary access and construction activities to advance the project.

### Be it resolved by the Council of the City of Pittsburgh as follows:

**Section 1.** The Director of the Department of Finance and the Director of the Department of Mobility and Infrastructure, on behalf of the City of Pittsburgh, are authorized to enter into certain agreements of sale with various property owners for construction purposes necessary to advance the Mt. Washington Landslide Remediation Project as further provided below and in the plan attached as Exhibit A.

**Section 2.** Costs relating to the agreements of sale are to be paid from the following account(s), in an amount

not to exceed Two Hundred and seventy Eight Thousand Five and Hundred Dollars (\$278,500.00) as indicated in the funding table:
