Resolution amending Resolution No. 679 of 2012, which authorized the City of Pittsburgh to enter into a Project and License Agreement with Riverlife to provide capital improvements & renovations to Allegheny Landing Park, by further authorizing a City contribution to dock repair work at a cost not to exceed One Hundred Fifty Thousand Dollars (\$150,000.00).

### Be it resolved by the Council of the City of Pittsburgh as follows:

Resolution No. 679 of 2012, entitled “Resolution authorizing the Mayor and the Director of the Department of Public Works and the Department of Parks and Recreation to enter into a Project and License Agreement with Riverlife to provide capital improvements/renovations to Allegheny Landing Park,” is hereby amended as follows:

**Section 1.** The Mayor and the Director of the Department of Public Works and the Director of the Department of Parks and Recreation **and/or the Director of the Office of Management and Budget** are hereby authorized to enter into a Project and License Agreement or Agreements with Riverlife, pursuant to which Riverlife will make renovations/capital improvements to Allegheny Landing Park. The Project and License Agreement or Agreements shall be approved by the City Solicitor as to form ~~and substance~~.

**Section 2.** The City contribution for dock repair work shall not exceed \$150,000.00, chargeable to and payable from Account Code 11101.102200.58.58101.2023.
