Resolution authorizing the Mayor and the Director of the Department of Public Safety to enter into an Agreement or Agreements with the Department of Justice COPS Mini Grant Program for the purpose of receiving and spending grant funds in the amount of ONE HUNDRED FIFTY THOUSAND FIVE HUNDRED (\$150,500.00) dollars to support the Police Inside-Out training program with program partner Duquesne University.

Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1. The Mayor and the Director of the Department of Public Safety, on behalf of the City of Pittsburgh, are authorized to enter into an Agreement or Agreements with the Department of Justice COPS Mini grant Program in order to receive a grant award of ONE HUNDRED FIFTY THOUSAND FIVE HUNDRED (\$150,500.00) dollars. Monies from the grant agreement shall be deposited into the Grants Trust Fund account 2329400408.45700.00.

Section 2. The Mayor and the Director of the Department of Public Safety, on behalf of the City of Pittsburgh, are further authorized to enter into an Agreement, or Contract, or utilize existing Agreements or Contracts, to make all legitimate expenditures required by said Agreement(s) as outlined in Section 1. Said expenditures shall not to exceed of ONE HUNDRED FIFTY THOUSAND FIVE HUNDRED (\$150,500.00), chargeable to and payable from the appropriate expense account in the Grants Trust Fund job number 2329400408.
