Resolution amending Resolution No. 342 of 2022, which authorized the Mayor and Department of Parks and Recreation to enter, on behalf of the City of Pittsburgh, into an agreement or agreements with Allegheny County, Department of Human Services, for the City's operation of its Senior Community Centers, for the purpose of increasing the allocation amount by TWO THOUSAND DOLLARS (\$2,000.00).

## Be it resolved by the Council of the City of Pittsburgh as follows:

**Section 1.** The Mayor and the Director of the Department of Parks and Recreation to enter on behalf of the City of Pittsburgh into an agreement or agreements with the Allegheny County, Department of Human Services, for the City's operation of its Senior Community Centers. Said agreement or agreements shall be for a term of one year at no cost to the City with compensation to the City not to exceed SEVEN HUNDRED EIGHTY-THREE FIVE THOUSAND and FOUR HUNDRED FIFTY DOLLARS and NO CENTS (\$783,450.00) \$785,450.00).

**Section 2.** Said agreements shall be in a form approved by the City Solicitor, The City Controller shall deposit funds received from Allegheny County pursuant to said agreement or agreements into the following chart account: 5000285000.45115.00.

Section 3. In all other respects, Resolution No. 342 of 2022, effective July 10, 2022, remains unchanged and in full force and effect.
