Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1. Section 1 of Resolution No. 448, effective August 19, 1998, as amended by Resolution No. 545, effective August 20, 2001, and Resolution No. 746, effective November 18, 2002, which currently reads:

"Section 1. The Mayor and the Director of the Department of City Planning, on behalf of the City of Pittsburgh, are hereby authorized and directed to enter into a Cooperation Agreement or Agreements with the Urban Redevelopment Authority of Pittsburgh, in a form approved by the City Solicitor, under which the Urban Redevelopment Authority of Pittsburgh will undertake the following programs and activities in connection with

the 1998-1999 Community Development Block Grant Program at a cost not to exceed Nine Million Three Hundred Twenty-Eight Thousand Eight Hundred (\$9,328,800.00) DOLLARS, chargeable to and payable from the 1998-1999 Community Development Block Grant Trust Fund as follows:
