Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1. Section 1 of Resolution No. 570, effective August 8, 2000, which currently reads:

"Section 1. The Mayor and the Director of the Department of City Planning, on behalf of the City of Pittsburgh, are hereby authorized and directed to enter into a Cooperation Agreement or Agreements with the Urban Redevelopment Authority of Pittsburgh, in a form approved by the City Solicitor, under which the Urban Redevelopment Authority of Pittsburgh will undertake the following programs and activities in connection with the 2000 Community Development Block Grant Program at a cost not to exceed One Million Sixty-Five Thousand (\$1,065,000.00) Dollars, chargeable to and payable from the 2000 Community Development Block
