Further amending Resolution No. 371, effective June 13, 2002, entitled "Providing for the execution of a Cooperation Agreement or Agreements with the Urban Redevelopment Authority of Pittsburgh for the performance of certain work in connection with the 2002 Community Development Block Grant Program, and providing for the payment of the cost thereof (Business Development Programs)" by decreasing Business Growth Fund by \$150,000 and transferring the funds to Urban Development Fund. (Council Districts: All).

Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1. Section 1 of Resolution No. 371, effective June 13, 2002, as amended by Resolution No. 134, effective March 18, 2005, which currently reads:

"Section 1. The Mayor and the Director of the Department of City Planning, on behalf of the City of Pittsburgh, are hereby authorized and directed to enter into a Cooperation Agreement or Agreements with the Urban Redevelopment Authority of Pittsburgh, in a form approved by the City Solicitor, under which the Urban

Redevelopment Authority of Pittsburgh will undertake the following programs and activities in connection with the 2002 Community Development Block Grant Program at a cost not to exceed One Million Three Hundred Forty-Three Thousand Eight Hundred Twenty-Seven (\$1,343,827) Dollars, chargeable to and payable from the 2002 Community Development Block Grant Trust Fund as follows:
