IOTA PHI Foundation of Pittsburgh, Inc.was founded in Pittsburgh, Pennsylvania in 1925 by brothers Louis Bellinger, a graduate of Howard University School of Architecture, Oliver P. Johnson, a graduate of Howard University School of Law, Bertram Woodruff, a graduate of University of Pittsburgh, and Pussell Anderson also a graduate of University of Pittsburgh; and

Whereas, Omega men have served the Pittsburgh area since 1925. Among them: William P. Young, first black Secretary of Labor and Industry for the Commonwealth of Pennsylvania; Oliver P. Johnson, first black District Attorney of Allegheny County; Paul Jones, first black to serve on City Council, and John M, Brewer, first black Principal of a Pittsburgh Public School.
