Resolution authorizing the City of Pittsburgh to issue a quit claim deed for property in the 19th and 20th Wards of the City of Pittsburgh to the Pennsylvania Department of Transportation for required right-of-way and temporary construction easements for State Route 19, Section A-27, generally known as the West End Circle Improvement Project, for property located on Steuben Street, South Main Street, Neptune Street and Greenleaf Street. The total consideration for this property is \$35,750.00 dollars.

Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1.

Whereas; Said properties are no longer needed by the City of Pittsburgh.
