Resolution providing for the designation as a Historic Structure under Title 11 of the Code of Ordinances that certain structure known as the former Workingmen' Savings Bank, located at 800 E Ohio Street, block and lot number 24-N-142, in the 23<sup>rd</sup> Ward, City of Pittsburgh.

Read and referred

WHEREAS, the City of Pittsburgh has duly enacted Title 11of the Code of Ordinances, which protects and preserves Historic Structures, Districts, Sites, and Objects; and

WHEREAS, the East Allegheny Community Council and the Allegheny City Society have nominated the former Workingmen's Savings Bank (800 E Ohio) for designation as a Historic Structure; and

WHEREAS, the Historic Review Commission has held a public hearing to gather testimony from the property owner and other interested parties concerning the appropriateness of this designation; and

WHEREAS, the Historic Review Commission has voted to recommend that City Council DESIGNATE the

former Workingmen's Savings Bank (800 E Ohio) as a Historic Structure; and

WHEREAS, the City Planning Commission has held a public hearing to gather testimony from the property owner and other interested parties concerning the appropriateness of this designation; and

WHEREAS, the City Planning Commission has not voted to recommend, or not recommend, that City Council DESIGNATE the former Workingmen's Savings Bank (800 E Ohio) as a Historic Structure; and

WHEREAS, the Council of the City of Pittsburgh has held a public hearing to gather testimony from the public concerning the appropriateness of this designation; and

WHEREAS, the Council of the City of Pittsburgh finds that the aforementioned building is a Historic Structure that should be preserved;

## Be it resolved by the Council of the City of Pittsburgh as follows:

**Section 1.** Pursuant to the provisions of Title 11 of the Code of Ordinances, the Council of the City of Pittsburgh hereby designates as a Historic Structure the building known as the former Workingmen's Savings Bank, located at 800 E Ohio Street, block and lot number 024-N-142, in the 23<sup>rd</sup> Ward, City of Pittsburgh.
