Resolution providing for the designation as an Historic Structure under Title 11 of the Code of Ordinances that certain structure known as the Old Stone Tavern, located at 434 Greentree Road, block and lot number 19-S-156, in the 20th Ward, City of Pittsburgh.

WHEREAS, the City of Pittsburgh has duly enacted Title 11 of the Code of Ordinances, which protects and preserves Historic Structures, Districts, Sites, and Objects; and

WHEREAS, Pittsburgh resident John DeSantis has nominated the Old Stone Tavern (434 Greentree Road) for designation as an Historic Structure; and

WHEREAS, the Historic Review Commission has held a public hearing to gather testimony from the property

owner and other interested parties concerning the appropriateness of this designation; and

WHEREAS, the Historic Review Commission has voted to recommend that City Council DESIGNATE the Old Stone Tavern (434 Greentree Road) as an Historic Structure; and

WHEREAS, the City Planning Commission has held a public hearing to gather testimony from the property owner and other interested parties concerning the appropriateness of this designation; and

WHEREAS, the City Planning Commission has voted to recommend that City Council DESIGNATE the Old Stone Tavern (434 Greentree Road) as an Historic Structure; and

WHEREAS, the Council of the City of Pittsburgh has held a public hearing to gather testimony from the public concerning the appropriateness of this designation; and

WHEREAS, the Council of the City of Pittsburgh finds that the aforementioned building is an Historic Structure that should be preserved;

Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1. Pursuant to the provisions of Title 11 of the Code of Ordinances, the Council of the City of Pittsburgh hereby designates as an Historic Structure the building known as Old Stone Tavern, located at 434 Greentree Road, block and lot number 19-S-156, in the 20th Ward, City of Pittsburgh.
