Resolution authorizing the Mayor to enter into a grant agreement with the Pennsylvania Department of Community and Economic Development to receive monies to support the Taking Care of Business Districts Program, a City-wide Business Districts Improvement Program, and further providing for legitimate expenditures for payments and agreement or agreements, or contract or contracts for any services required in connection with the execution of said grant agreement. Said agreement or agreements, contract or contracts or expenditures shall not exceed \$150,000.

Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1. The Mayor and the Director of Public Works are hereby authorized to enter into a Grant Agreement with the Pennsylvania Department of Community and Economic Development for the receipt of grant monies in the amount of one hundred and fifty thousand dollars (\$150,000.00). These funds will be used to support the Mayor's Taking Care of Business District Program. The Grant Agreement shall be approved as to form and substance by the City Solicitor and monies shall be deposited into the Grants Trust Fund: account 450500, fund 2940, organization code 400000, project PR10032, budget year 2009, Department of Public Works .

Section 2. The Director of Public Works, on behalf of the City of Pittsburgh, is hereby further authorized to enter into agreement or agreements, contract or contracts, and to make all legitimate expenditures required under the terms and conditions of the Grant Agreement with the Pennsylvania Department of Community and Economic Development outlined in Section 1 of this resolution. Said agreement or agreements, contract or contracts, or expenditures shall not exceed one hundred and fifty thousand dollars (\$150,000.00) chargeable to and payable from the Grants Trust Fund: account 600000, fund 2940, organization code 400000, project PR10032, budget year 2009, Department of Public Works.
