Title: Resolution Repealing Resolution No. 775, effective December 31, 2009 entitled: by providing for the filing of a Community Development statement by the City of Pittsburgh with the U.S. Department of Housing and Urban Development for a grant in connection with the 2007 Community Development Block Grant Program; providing for the execution of grant contracts and for the filing of other data providing for required assurances; providing for execution of payment vouchers on letter of credit and for certification of authorized signature; the deposit of the funds in a bank account and providing for the payment of expenses within categories; so as to reprogram funds in City Council from the "Breachmenders Ministries" (-\$5,000), and from "Mercy Hospital of Pgh.-Children's Medical Center" (-\$4,500), and from "Hill District Dodgers Baseball Team" (-\$1,000), and from "New Hill District Business Association" (-\$2,500), and from "Small Seeds Development" (-\$2,500); and transfer these funds to "Community Human Services" (+\$10,500), and to "Reading is Fundamental" (+\$5,000).
