**Section 1.** The Mayor, on behalf of the City of Pittsburgh, is hereby authorized to enter into a Cooperation Agreement or Agreements with the Urban Redevelopment Authority of Pittsburgh, in a form approved by the City Solicitor, under which the Urban Redevelopment Authority of Pittsburgh will undertake the certain programs and projects at a cost not to exceed Two Million Two Hundred Fifty Thousand (\$2,250,000) Dollars, chargeable to and payable from the following account:
