## Be it resolved by the Council of the City of Pittsburgh as follows:

**Section 1.** That Section 1 of Resolution No. 592, effective December 13, 2004, as amended by Resolution No. 63, effective February 20, 2008, is hereby further amended as follows:

The Mayor and the Director of the Department Finance, on behalf of the City, are hereby authorized to enter into an Agreement or Agreements and Lease or Leases, approved inform and substance by the Mayor, Director

of the Department and the City Solicitor, for the furnishing of all supervision, labor, parts, supplies and sub-contract work needed to manage and maintain the City's fleet of vehicles in a state of repair consistent with the performance standards and service specifications required by the Department, said Agreement, Agreements, Lease or Leases to be for a period of Three (3) years, with an option by the City to extend the term for an additional twenty-seven (27) months, from February 22, 2008 through May 31, 2010, and thereafter on a month to month basis for up to six (6) months.

**Section 2.** That Section 2 of Resolution No. 592, effective December 13, 2004, as amended by Resolution No. 320, effective June 15, 2007, as amended by Resolution No. 63, effective February 20, 2008, is hereby further amended as follows:

Funds for implementation of target costs exclusively for the extended period of no more than six (6) months after May 31, 2010, on a month to month basis, under the Agreement or Agreements or Amending Agreements or Lease or Leases or Amending Leases in the amount not to exceed **Two Million Four Hundred Ninety-Three Thousand Two Hundred Seventy-Six Dollars (\$2,493,276)** Four Million Five Hundred Seventy-One Thousand Six Dollars (\$4,571,006) shall be appropriated for the same, chargeable to and payable from the following accounts:

**Section 3.** That Section 3 of Resolution No. 592, effective December 13, 2004, as amended by Resolution No. 320, effective June 15, 2007, as amended by Resolution No. 63, effective February 20, 2008, is hereby further amended as follows:

Other associated costs, which includes but is not limited to transition related charges, non-target costs, and emergency expenditures, and which as in addition to the Target Costs outlined in Section 2

Additional funding for other associated costs during the said extended period of no more than six (6) months after May 31, 2010, on a month to month basis, which includes but is not limited to transition related charges, non-target costs and emergency expenditures, and which as in addition to the Target Cost outlined in Section 2, shall be in an amount not to exceed **Eight Hundred Seventy Four Thousand Eight Hundred Dollars** (\$874,800) One Million Five Hundred Twenty Thousand Four Hundred Sixty-Seven Dollars (\$1,520,467.00) chargeable to and payable from the following accounts.
