**Be it resolved by the Council of the City of Pittsburgh as Follows:**

**Section 1.** The Mayor and Director of the Department of Permits, Licenses and Inspections, on behalf of the City of Pittsburgh, are hereby authorized to enter into an Amended Agreement or Agreements with ath Power Consulting Corporation to provide customer service and soft skills training to the Department’s staff **by increasing the approved amount by FORTY-FIVE THOUSAND DOLLARS AND ZERO CENTS (\$45,000.00) for an amended total cost not-to-exceed ONE HUNDRED TWENTY-THREE THOUSAND ONE HUNDRED FIFTY DOLLARS AND ZERO CENTS (\$123,150.00) over 4 years.**
