Whereas, the Urban Redevelopment Authority of Pittsburgh has requested authorization to execute a Contract for Disposition by Sale of Land by and between the Urban Redevelopment Authority of Pittsburgh and Shawna Bridgett in connection with the sale of Block 9-M, Lot 182, for \$500.00, said property being located in the 3rd Ward of the City of Pittsburgh; and

Whereas, this property has been acquired by monies from the Residential Land Reserve Fund; and

Whereas, the Council of the City of Pittsburgh believes that the proposed Contract is in the best interest of the

## Be it resolved by the Council of the City of Pittsburgh as follows:

**Section 1.** That execution of the Contract for Disposition by Sale of Land by and between the Urban Redevelopment Authority of Pittsburgh and Shawna Bridgett for the sale of Block 9-M, Lot 182, in the 3rd Ward of the City of Pittsburgh for \$500.00, be and the same is hereby approved, said Contract being in conformity with the terms and conditions of the Residential Land Reserve Fund Cooperation Agreement.
