Resolution authorizing the Mayor and Director of the Department of Public Works, on behalf of the City of Pittsburgh, to enter into a Project Labor Agreement or Agreements with the Pittsburgh Regional Building and Construction Trades Council, AFL-CIO (“Building Trades”), that will apply to all phases of installation of the City’s LED street light conversion construction project, at no cost to the City
(Executive Session held 10/1/24)

WHEREAS, pursuant to Resolution No. 708 of 2011, the City of Pittsburgh is authorized to enter into a Project Labor Agreement with the Building Trades, that will apply to all phases of installation of the City’s LED street light conversion construction project.

WHEREAS, both the City and the Building Trades identified certain provisions in the Project Labor Agreement that may be contrary to recent court decisions;

WHEREAS, the City and the Building Trades wish to amend the Project Labor Agreement to ensure that agreement is in compliance with recent court decisions;

Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1. Resolution authorizing the Mayor and Director of the Department of Public Works, on behalf of the City of Pittsburgh, to enter into a Project Labor Agreement or Agreements with the Pittsburgh Regional Building and Construction Trades Council, AFL-CIO that will apply to all phases of installation of the City's LED street light conversion construction project.

Section 2. Said Agreement or Agreements shall be approved by the City Solicitor as to form.
