Resolution authorizing the Mayor and the Director of Public Safety to enter into a Professional Service Agreement or Agreements with United Diagnostics Services, for professional services relating to voluntary health screenings for all Bureau of Fire personnel, for a total cost not to exceed ONE MILLION ONE HUNDRED SEVENTY-EIGHT THOUSAND **ONE HUNDRED TWENTY FIVE** DOLLARS (\$1,178,00125.00) over five years.

Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1. The Mayor and the Director of Public Safety are hereby authorized to enter into a Professional Service Agreement or Agreements with United Diagnostics Services, for professional services relating to voluntary health screenings for all Bureau of Fire personnel for a total cost not to exceed ONE MILLION ONE HUNDRED SEVENTY-EIGHT THOUSAND **ONE HUNDRED TWENTY FIVE** DOLLARS (\$1,178,00125.00) over five years.

Section 2. Funds for said agreement shall be chargeable and payable from the following chart of accounts:
