Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1. Resolution No. 768, effective January 1, 2010, entitled: "Adopting and approving the 2010 Capital Budget and the 2010 Community Development Block Grant Program; and approving the 2010 through 2014 Capital Improvement Program," is hereby amended and supplemented by increasing the amount of CDBG funds from \$16,500,000 to \$18,038,480 to reflect the final approved grant amount from the U.S. Department of Housing and Urban Development.
