Resolution authorizing the Mayor and the City Controller to enter into a Professional Service Agreement and/or Contract with The Binkley Kanavy Group, LLC for services associated with the Popular Annual Financial Report, including accounting services, production, printing, and mailing. Cost not to exceed Forty Thousand Three Hundred Dollars and Zero Cents (\$40,300) over a term of two years.

Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1. The Mayor and the City Controller, on behalf of the City of Pittsburgh, are hereby authorized to enter into a Professional Service Agreement and/or Contract with the Binkley Kanavy Group, LLC for services associated with the Popular Annual Financial Report, including accounting services, production, printing, and mailing. Cost not to exceed Forty Thousand Three Hundred Dollars and Zero Cents (\$40,300) over a term of two years.

Funds shall be allocated and encumbered as follows, subject to Council approval in future budget years:

2025: \$20,150 from 11101.106000.53.53501.2025

2026: \$20,150 from 11101.106000.53.53501.2026

Section 2. The Agreement(s) and/or Contract(s) shall be approved by the City Solicitor as to form and substance.

Section 3. Any ordinance or Resolution or part thereof conflicting with the provisions of this Resolution is

hereby repealed so far as the same affects this Resolution.
