Resolution authorizing the issuance of a warrant in favor of the Sheraton Hotel Station Square in an amount not to exceed twelve thousand one hundred forty eight dollars and forty cents (\$12,148.40), for the Citiparks Seniors Program Volunteer Recognition Gala; and providing for the payment thereof.

## Be it resolved by the Council of the City of Pittsburgh as follows:

**Section 1.** The Mayor is hereby authorized to issue and the City Controller to countersign a warrant in favor of the Sheraton Hotel Station Square in an amount not to exceed twelve thousand one hundred forty eight dollars and forty cents (\$12,148.40), in payment of the Citiparks Seniors Program Volunteer Recognition Gala; without previous authority of law, chargeable to and payable from Account 526100, Fund 2850, Organization 530000, Subclass 600, Year 2010, in the Department of Parks and Recreation.
