Resolution amending Resolution No. 693, effective November 19, 2009, entitled "Authorizing the Urban Redevelopment Authority of Pittsburgh to submit an Application to the Pennsylvania Office of the Budget for a Redevelopment Assistance Capital Program grant of up to \$250,000 for the Phipps Conservatory Phase III project." by increasing the grant to \$500,000. (Council Districts 3 and 5)

Whereas, by Resolution No. 693, effective November 19, 2009, the Council of the City of Pittsburgh authorized Urban Redevelopment Authority of Pittsburgh ("URA") to submit an application to the Commonwealth of Pennsylvania Office of the Budget (the "Commonwealth") for a grant under the Redevelopment Assistance Capital Program ("RACP") in the amount of \$250,000 for the Phipps Conservatory Phase III project (the "Project"); and

Whereas, the Commonwealth has increased the grant to \$500,000, which requires an amendment to Resolution No. 693 to reflect the increased grant;

Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1. Section 1 of Resolution No. 693, effective November 19, 2009, which currently reads as follows:
