authorized to enter into a Reimbursement Agreement with the Commonwealth of Pennsylvania, Department of Transportation to receive \$280,000.00 in reimbursement funding. These funds will be used for all legitimate expenditures required under the terms and conditions of the Reimbursement Agreement with the Commonwealth of Pennsylvania, Department of Transportation for the Strip District Transportation and Land Use Sustainability Model. The Reimbursement Agreement shall be approved as to form and substance by the City Solicitor and monies deposited into the Grants Trust Fund:
