Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1. The Mayor is hereby authorized to issue and the City Controller to countersign a warrant to be issued in the amount of \$150,000, in full and final settlement of any and all claims filed in the United States District Court for the Western District of Pennsylvania, at 2:08-cv-1185 and charge the same code to Code Account 46, Index Code 004606, Fund 1000, Sub 170, Account 592200, Org. 999200 Budget Year 2011.
