Resolution amending Resolution No. 781, effective November 12, 2010, entitled: Resolution providing for an Agreement or Agreements with various community organizations for operational/administrative expenses, maintenance, purchase of equipment; and/or rehabilitation of neighborhood facilities; and for administrative/operational costs, maintenance, purchase of equipment, and/or rehabilitation of neighborhood facilities of various departmental programs/projects for the benefit of residents of the City of Pittsburgh, at a cost not to exceed \$918,650.00; so as to reprogram funds in City Council from "District 2 - Public Works" (- \$10,500.00); and transferring these funds to "MWCD WILD Arts Trails Festival (+ \$1,000.00); and to the "Pittsburgh Musical Theater" (+ 2,500.00); and to the "Western PA Police Athletic League" (+ 5,000.00); and to the "Ream Recreation Center" (+ \$2,000.00).

**Be it resolved by the Council of the City of Pittsburgh as follows:**

**Section 1.** Amending Resolution No. 781, effective November 12, 2010, which presently reads as follows:

The Mayor and the Director of City Planning, on behalf of the City of Pittsburgh, are hereby authorized to enter into an Agreement or Agreements, in a form approved by the City Solicitor, with the following various community organizations for operational/administrative expenses; maintenance, and/or rehabilitation of neighborhood facilities; and for administrative/operational costs, maintenance, purchase of equipment, and/or rehabilitation of neighborhood facilities of various departmental programs/projects for the benefit of residents of the City of Pittsburgh, at a cost not to exceed \$918,650.00, chargeable to and payable from the 2010 Community Development Block Grant Program and the listed code accounts in the City Council.
