Ordinance supplementing the Pittsburgh Code, Title Six, Conduct, Article I Regulated Rights and Actions, Chapter 619 Refuse Collection and Recycling by adding a new section, entitled, Section 619.18 Refuse Collection Times in Residential Zones.

Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1. The Pittsburgh Code is hereby supplemented at Title Six, Conduct, Article I Regulated Rights and Actions, Chapter 619 Refuse Collection and Recycling by adding a new section, entitled, Section 619.18 as follows:

619.18 Refuse Collection Times in Residential Zones

(a) No person shall operate any trash, rubbish, garbage, or <u>recycling</u> collection activities within any residentially zoned district or within 1,000 feet of any residentially zoned district between the hours of 10:00 p.m. and 6:00 a.m.

(b) A violation of Section 619.18(a) shall be governed by this subsection instead of the penalties otherwise set forth in Section 619.15. Any person found to have violated Section 619.18(a) shall be subject to a fine

of three hundred dollars (\$300.00) plus costs for first and all subsequent offenses. Each collection activity within the prohibited hours set forth in Section 619.18(a) shall constitute a separate and distinct offense.

(c) This section shall be enforceable by the Pittsburgh Bureau of Police, Department of Public Works, or the Bureau of Building Inspection.
