Herman, Geer and Herman, P.C., 2100 Wilmington Road, New Castle, PA 16105, in settlement of an action filed in the Court of Common Pleas of Allegheny County, Pennsylvania at GD 04-027465 for personal injuries and damages arising from a pedestrian-automobile accident on or about September 30, 2003, at or near the intersection of Braddock Avenue and Guthrie Street in the City of Pittsburgh, Allegheny County, Pennsylvania.

Be it resolved by the Council of the City of Pittsburgh as follows:
