## Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1. Section 2 of Resolution No. 589, effective August 10, 2010, which currently reads as follows:

"Section 2. The Mayor is hereby authorized to enter into a TIGER II/Community Challenge Planning Grant Cooperation Agreement with Urban Redevelopment Authority of Pittsburgh, in a form approved by the City Solicitor, designating URA as the City's agent for administration of a \$1,500,000 Transportation Investment Generating Economic Recovery ("TIGER II")/Community Challenge Planning Grant from the U.S. Department of Transportation or the U.S. Department of Housing and Urban Development
