WHEREAS, Women for a Healthy Environment is hosting a public forum on June 7, 2011 entitled "Face It... Healthy Beauty from the Inside Out" that focuses on the safety of personal care products and cosmetics, including a panel discussion with experts as well as an opportunity to purchase safe products from retailers in the region; and

WHEREAS, Women for a Healthy Environment is collaborating with the Campaign for Safe Cosmetics to offer an educational workshop on June 8, 2011 entitled "Using Our Voices: The Campaign for Safe Cosmetics Advocacy Training Workshop" for girl-serving agencies in southwestern Pennsylvania to participate in a unique information-sharing and skill-building forum; and
