**WHEREAS, Sam Costanzo** has devoted his life to the cause of juvenile rehabilitation and is the architect, guiding hand, driving force and CEO behind The Academy Charter School, Sleepy Hollow Academy, Summit Academy, and The Academy, all of which take delinquent children from the court system and put them through a unique, high quality rigorous series of programs including academics, counseling, industrial trades training, athletics and community service in a totally therapeutic environment to turn their lives around from a life of crime to a life as productive members of society; and

**WHEREAS, Mr. Costanzo's** facilities have twice been recognized with the highest recognition by the Commission on Accreditation of Rehabilitation Facilities or CARF, an independent, non-profit accreditor of health and human services which evaluates facilities to ensure that their programs, services and employees are of the highest quality; and
