Resolution amending Resolution No. 715, effective November 28, 2012, providing for an Agreement or Agreements with various community organizations for operational/administrative expenses, maintenance, purchase of equipment; and /or rehabilitation of neighborhood facilities; and for administrative/operational costs, maintenance, purchase of equipment, and/or rehabilitation of neighborhood facilities of various departmental programs/projects for the behalf of residents of the City of Pittsburgh, at a cost not to exceed \$800,000.00; so as to reprogram funds in the Mayor's Office from: "West End Alliance c/o West Pittsburgh Partnership" (-\$50,000.00), and transfer these funds to "Jerusalem Baptist Church" (+\$10,000.00), "Neighborhood Learning Alliance/West End Works Employment Center" (+\$20,000.00) and "Youth Places/REAM Recreation Center" (+\$20,000.00).

Amending Resolution No. 715, effective November 28, 2012, which presently reads as follows:

Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1. The Mayor and the Director of City Planning, on behalf of the City of Pittsburgh, are hereby authorized to enter into an Agreement or agreements, in the form approved by the City Solicitor, with the following various community organizations for operational/administrative expenses, maintenance, purchase of equipment; and /or rehabilitation of neighborhood facilities; and for administrative/operational costs, maintenance, purchase of equipment, and/or rehabilitation of neighborhood facilities of various departmental programs/projects for the behalf of residents of the City of Pittsburgh, at a cost not to exceed \$800,000.00, chargeable and payable from the 2011 Community Development Block Grant Program, and listed code accounts in the Mayor's Office.
