Resolution requesting the approval of an inter-municipal transfer of a liquor license, License No. R-12176 , from BOKA, Inc. located at 3942 William Penn Hwy, Monroeville, PA 15146 to the Applicant, Kura Sushi USA, Inc. (d/b/a "Kura Revolving Sushi Bar"), located at 415 Cinema Drive, Pittsburgh, PA 15203, pursuant to amended Pennsylvania Liquor Code, §4-461.

**Be it resolved by the Council of the City of Pittsburgh as follows:**

**Section 1.** The Council of the City of Pittsburgh hereby endorses the request for approval of an inter-municipal transfer of a liquor license, License No. R-12176 from BOKA, Inc. located at 3942 William Penn Hwy, Monroeville, PA 15146 to the Applicant, Kura Sushi USA, Inc. (d/b/a "Kura Revolving Sushi Bar") located at 415 Cinema Drive, Pittsburgh, PA 15203, for the premises located at 415 Cinema Drive, Pittsburgh, PA 15203, known as Kura Sushi USA, Inc. (d/b/a "Kura Revolving Sushi Bar"), pursuant to amended Pennsylvania Liquor Code, §4-461.

**Section 2.** Request for Approval

Kura Sushi USA, Inc., (d/b/a "Kura Revolving Sushi Bar"), which has a mailing address of 17461 Derian Ave. Suite 200, Irvine, CA 92614, submitted a request for approval of an inter-municipal transfer of a restaurant liquor license, License No. R-12176 , which is currently registered to BOKA, Inc. located at 3942 William Penn Hwy, Monroeville, PA 15146, desires to place a liquor license into premises known as Kura Sushi USA, Inc. (d/b/a "Kura Revolving Sushi Bar") and numbered as 415 Cinema Drive, Pittsburgh, PA 15203. The proposed interior of the premises is 3,809 square foot floor area.

**Section 3.** Public Hearing

City Council shall set a date for Public Hearing for the purpose of receiving comments and recommendations of interested individuals residing in the City of Pittsburgh concerning intent to transfer the above liquor license.

**Section 4.** Approval or Denial of Request

After the Public Hearing which was held May 15, 2023, and within 45 days of the introduction of this Resolution, City Council shall render a decision to approve or disapprove the request of Kura Sushi USA, Inc. (d/b/a "Kura Revolving Sushi Bar"), for inter-municipal transfer of a restaurant liquor license. City Council must approve Kura Sushi USA, Inc.'s (d/b/a "Kura Revolving Sushi Bar") request unless it finds that approval
