Resolution requesting the approval of an inter-municipal transfer of a restaurant liquor license, License No. R-19951, from Golden Shamrock Corporation, 4268 Verona Road, Pittsburgh, PA 15147 to R & G, Inc., c/o Richard J. Krist, President, 314 Avonworth Heights Drive, Verona, PA 15237, for the premises, located at 2023 Penn Avenue, Pittsburgh, PA 15222 known as ~~Riek's~~ Lefty's Bar in the Strip, pursuant to amended Pennsylvania Liquor Code, §4-461.

**Be it resolved by the Council of the City of Pittsburgh as follows:**

**Section 1.** The Council of the City of Pittsburgh hereby endorses the request for approval of an inter-municipal transfer of a restaurant liquor license, License No. R-19951, from Golden Shamrock Corporation, 4268 Verona Road, Verona, PA 15147 to R & G, Inc., c/o Richard J. Krist, President, 314 Avonworth Heights Drive, Pittsburgh, PA 15237, for the premises, located at 2023 Penn Avenue, Pittsburgh, PA 15222 known as ~~Riek's Bar~~ Lefty's Bar in the Strip, pursuant to amended Pennsylvania Liquor Code, §4-461.

**SECTION 2.** Request for Approval

R & G, Inc., c/o Richard J. Krist, President, which has a mailing address of 314 Avonworth Heights Drive, Pittsburgh, PA 15237, submitted a request for approval of an inter-municipal transfer of a restaurant liquor license, License No. R-19951, which is currently registered to Golden Shamrock Corporation, 4268 Verona Road, Verona, PA 15147, desires to place a restaurant liquor license into premises known and numbered as 2023 Penn Avenue, Pittsburgh, PA 15222. The proposed interior of the premises is space for the restaurant/tavern business which will be a sports bar.

**SECTION 3.** Public Hearing

City Council shall set a date for Public Hearing for the purpose of receiving comments and recommendations of interested individuals residing in the City of Pittsburgh concerning R & G, Inc., c/o Richard J. Krist's intent to the above liquor license.

**SECTION 4.** Approval or Denial of Request

After the Public Hearing which was held Tuesday, December 6, 2005, and within 45 days of the introduction of this Resolution, City Council shall render a decision to approve or disapprove of R & G, Inc., c/o Richard J. Krist's request for inter-municipal transfer of a restaurant liquor license. City Council must approve R & G, Inc., c/o Richard J. Krist's request unless it finds that approval would adversely affect the welfare, health, peace and morals of the City of Pittsburgh or its residents.
